#### **Starting Bid**

#### **Auctioneer Authority**

#### **Re-opening or Re-offering Lots**

If you have entered an Absentee Bid online through the Live Auctions system, it will be impossible to register such bids on your behalf.

#### **Payment Instructions**

For every lot on which you are the successful bidder, Sotheby's will send you an invoice within a few days after the sale. In addition to the high bid (hammer price), the charges will include:

- **Buyer's Premium**  
A buyer's premium will be added to the successful bid price and is payable by the purchaser as part of the total purchase price. The buyer's premium will be the amount stated in the Conditions of Sale.
- **Sales Tax**  
Sales tax may be due on purchases, depending upon the location of the sale and the location of pickup or delivery of the property.

Sotheby's accepts cash, check or wire transfer, Visa, or MasterCard. Credit card payment must take place in person at Sotheby's or via a signed authorization letter and cannot exceed \$25,000. Note that when paying by check, you may not pick up your purchase until the check has cleared.

**Limitations on cash payments:** It is against Sotheby's general policy to accept single or multiple related payments in the form of cash or cash equivalents in excess of the local currency equivalent of US\$10,000. It is Sotheby's policy to request any new clients or purchasers preferring to make a cash payment to provide: verification of identity (by providing some form of government-issued identification containing a photograph, such as a passport, identity card or driver's license), confirmation of permanent address, and identification of the source of the funds.

#### **Shipping**

Successful purchasers should pick up their property by the tenth day following an auction.
